PRIVACY POLICY

Our data protection philosophy in one sentence: As a NGO with Special Consultative Status to UN/ECOSOC, it has always been our main priority, and in our own interest, to keep our members 'personal data safe; we do not share it with third parties or perform any automatic profiling.

The Lazarus Union is committed to safeguarding your personal rights. This includes the right to privacy, which is guaranteed by § 1328a ABGB 1b. (The Austrian Civil Code) and article 8 of the European Convention on Human Rights (ECHR).

We have written this privacy statement to explain to you, in accordance with the requirements of the European General Data Protection Regulation (EU-GDPR Regulation (EU) 2016/679), what information we collect, how we use data, and what choices you as a visitor to this website have (and all other websites that we operate independently in the course of our activities). Unfortunately, it is in the nature of the matter that these explanations sound very technical, but we have tried to describe the most important things easily and clearly in the creation of this privacy policy. The EU-GDPR will enter into force on 25 May 2018.

By using this site or/and our services, you consent to the Processing of your Personal Data as described in this Privacy Policy.

This Privacy Policy is a part of our Terms and Conditions; by agreeing to Terms and Conditions you also agree to this Policy. In the event of collision of terms used in Terms and Conditions and Privacy Policy, the latter shall prevail.

Definitions

Personal Data	any information relating to an identified or identifiable natural person.
Processing	any operation or set of operations which is performed on Personal Data or on sets of Personal Data.

Data Protection Principles

We promise to follow the following data protection principles:

- Processing is lawful, fair, transparent. Our Processing activities have lawful grounds. We always consider your rights before Processing Personal Data. We will provide you information regarding Processing upon request.
- Processing is limited to the purpose. Our Processing activities fit the purpose for which Personal Data was gathered.
- Processing is done with minimal data. We only gather and Process the minimal amount of Personal Data required for any purpose.
- Processing is limited with a time period. We will not store your personal data for longer than needed.
- We will do our best to ensure the accuracy of data.
- We will do our best to ensure the integrity and confidentiality of data.

Data Subject's rights

The Data Subject has the following rights:

- Right to information — meaning you have the right to know whether your Personal Data is being processed; what data is gathered, from where it is obtained and why and by whom it is processed.
- Right to access — meaning you have the right to access the data collected from/about you. This includes your right to request and obtain a copy of your Personal Data gathered.
- Right to rectification — meaning you have the right to request rectification or erasure of your Personal Data that is inaccurate or incomplete.
- Right to erasure — meaning in certain circumstances you can request for your Personal Data to be erased from our records.
- Right to restrict processing — meaning where certain conditions apply, you have the right to restrict the Processing of your Personal Data.
- Right to object to processing — meaning in certain cases you have the right to object to Processing of your Personal Data, for example in the case of direct marketing.
- Right to object to automated Processing — meaning you have the right to object to automated Processing, including profiling; and not to be subject to a decision based solely on automated Processing. This right you can exercise whenever there is an outcome of the profiling that produces legal effects concerning or significantly affecting you.
- Right to data portability — you have the right to obtain your Personal Data in a machine-readable format or if it is feasible, as a direct transfer from one Processor to another.
- Right to lodge a complaint — in the event that we refuse your request under the Rights of Access, we will provide you with a reason as to why. If you are not satisfied with the way your request has been handled please contact us.
- Right for the help of supervisory authority — meaning you have the right for the help of a supervisory authority and the right for other legal remedies such as claiming damages.
- Right to withdraw consent — you have the right to withdraw any given consent for Processing of your Personal Data.

Data we gather

Information you have provided us with

- This could be your email address, name, billing address, home address, etc. — mainly information necessary for the provision of a product/service or to improve your customer experience with us. We will store the information you provide to us so that you can comment or perform other activities on the website. This information includes your name and email address, for example. We therefore only use your personal data for the communication with those visitors who expressly want contact and for the processing of the services and products offered on this website. We do not disclose your personal information without consent, but we cannot rule out the fact that this data is viewed in the presence of unlawful conduct.

Information automatically collected about you

- This includes information that is automatically stored by cookies and other session tools. For example, your shopping cart information, your IP address, your shopping history (if there is any) etc. This information is used to improve your customer experience. When you visit any website these days, certain information is automatically created and stored — this is also the case on this website. If you visit our website as you are now, our web server (the computer on which this website is stored) automatically stores data such as the IP address of your device, the addresses of the visited sub-pages, details about your browser (e.g. Chrome, Firefox, Edge, ...) and date and time. We only use this data to identify problems with the programming of the site and do not normally pass this data on, but we cannot rule out that this data will be seen in the presence of unlawful behaviour.

- We might gather information about you that is publicly available.

How we use your Personal Data

We use your Personal Data in order to:

- provide our service to you. This includes for example registering your account; providing you with other products and services that you have requested; providing you with promotional items at your request and communicating with you in relation to those products and services; communicating and interacting with you; and notifying you of changes to any services.
- enhance your customer experience;
- fulfil an obligation under law or contract;
- We use your Personal Data on legitimate grounds and/or with your Consent.

On the grounds of entering into a contract or fulfilling contractual obligations, we Process your Personal Data for the following purposes:

- to identify you;
- to provide you a service or to send/offer you a product;
- to communicate either for sales or invoicing;
- On the ground of legitimate interest, we Process your Personal Data for the following purposes:
 - to send you personalized offers (from us and/or our carefully selected partners);
 - to administer and analyse our client base (purchasing behaviour and history) in order to improve the quality, variety, and availability of products/ services offered/provided;
 - to conduct questionnaires concerning client satisfaction;
 - As long as you have not informed us otherwise, we consider offering you products/services that are similar or same to your purchasing history/browsing behaviour to be our legitimate interest.

With your consent we Process your Personal Data for the following purposes:

- to send you newsletters and campaign offers (from us and/or our carefully selected partners);
- for other purposes we have asked your consent for;
- We Process your Personal Data in order to fulfil obligation rising from law and/or use your Personal Data for options provided by law. We reserve the right to anonymise Personal Data gathered and to use any such data. We will use data outside the scope of this Policy only when it is anonymised. We store your billing information and other information collected about you, as long as it is required for accounting purposes or other obligations from law, but no longer than the Austrian law requires.

We might process your Personal Data for additional purposes that are not mentioned here, but are compatible with the original purpose for which the data was gathered. To do this, we will ensure that:

- the link between purposes, context and nature of Personal Data is suitable for further Processing;
- the further Processing would not harm your interests and
- there would be appropriate safeguard for Processing.
- We will inform you of any further Processing and purposes.

Who else can access your Personal Data

We do not share your Personal Data with strangers. Personal Data about you is in some cases provided to our trusted partners in order to either make providing the service to you possible or to enhance your customer experience. We share your data with:

How we secure your data

We do our best to keep your Personal Data safe. We use safe protocols for communication and transferring data (such as HTTPS, SSL, TLS). We use anonymising and pseudonymising where suitable. We monitor our systems for possible vulnerabilities and attacks.

Even though we try our best we can not guarantee the security of information. However, we promise to notify suitable authorities of data breaches. We will also notify you if there is a threat to your rights or interests. We will do everything we reasonably can to prevent security breaches and to assist authorities should any breaches occur.

If you have an account with us (Web shop, Leadership Academy), note that you have to keep your username and password secret.

Children

We do not intend to collect or knowingly collect information from children. We do not target children with our services.

Cookies and other technologies we use

We use cookies and/or similar technologies to analyse customer behaviour, administer the website, track users' movements, and to collect information about users. This is done in order to personalise and enhance your experience with us.

A cookie is a tiny text file stored on your computer. Cookies store information that is used to help make sites work. Only we can access the cookies created by our website. You can control your cookies at the browser level. Choosing to disable cookies may hinder your use of certain functions. You can delete cookies that are already on your computer or disable cookies at any time. The procedure for doing this is different according to the browser, preferably you search the instructions in Google with the search term „delete cookies Chrome“ or „disable Cookies chrome“ in the case of a Chrome browser or swap

We use cookies for the following purposes:

- Necessary cookies — these cookies are required for you to be able to use some important features on our website, such as logging in. These cookies don't collect any personal information.
- Functionality cookies — these cookies provide functionality that makes using our service more convenient and makes providing more personalised features possible. For example, they might remember your name and e-mail in comment forms so you don't have to re-enter this information next time when commenting.
- Analytics cookies – these cookies are used to track the use and performance of our website and services
- Advertising cookies – these cookies are used to deliver advertisements that are relevant to you and to your interests. In addition, they are used to limit the number of times you see an advertisement. They are usually placed to the website by advertising networks with the website operator's permission. These cookies remember that you have visited a website and this information is shared with other organisations such as advertisers. Often targeting or advertising cookies will be linked to site functionality provided by the other organisation.
